Phase-Out | 802.1x certificate expiry for IP Touch 40x8 Phones

EF-Phase-out-CXXX-EN - Month DD, YYYY

ALE is notifying its partners that the root certificate used by the outdated Alcatel IP Touch 40x8 desktop phones for 802.1X authentication will expire on September 28, 2025.

Customers using outdated IP Touch 40x8 phones in networks relying on 802.1X authentication are advised to take preventive measures before the certificate expiration. After this date, affected phones will no longer be able to authenticate on 802.1X networks, potentially leading to service disruptions.

This eFlash is applicable in all countries worldwide except in territories where restricted by applicable export control rules.

Important notice and recommended actions

The root certificate used for the IP Touch 40x8 IP DeskPhones' 802.1X authentication will expire on September 28, 2025. After this date, affected phones will no longer be able to authenticate on 802.1X-secured networks, and they will cease to function, even if their internal certificates remain valid.

Devices operating in environments that do not use 802.1X authentication will remain unaffected by this certificate expiration and will continue to function as they did before this date.


Support for 802.1X authentication on IP Touch 40x8 phones has been deprecated, and these models are no longer supported (see table below). However, ALE is aware that some customers may still have these devices deployed in production environments.

Customers using these phones in networks relying on 802.1X authentication are strongly advised to take preventive measures before the certificate expiration.

ALE recommends the following actions to its partners:



- 1. Identify customers still using IP Touch IP DeskPhones. For Cloud Connected systems, this information can be accessed directly through the Cloud Connect operation in the inventory section. [A VERIFIER]
- 2. Verify whether the end customer's IP network is utilizing 802.1x access control:
 a. If no access control is active, no action is required. The certificate expiration will have no impact.
 b. If access control is active, the replacement of the 40x8 phones with newer ALE DeskPhones is mandatory.

We would also like to take this opportunity to remind you that ALE recommends regularly updating communication systems. This includes using the latest software versions and modern, supported terminals to ensure optimal cybersecurity. With a valid SPS contract, access to the latest releases and security patches is free of charge.

While some outdated devices may still operate on the latest releases, we strongly recommend checking the release compatibility to identify what is clearly supported, sustained, or deprecated. We encourage you to proactively modernize your existing infrastructure to ensure the highest level of security and performance.
